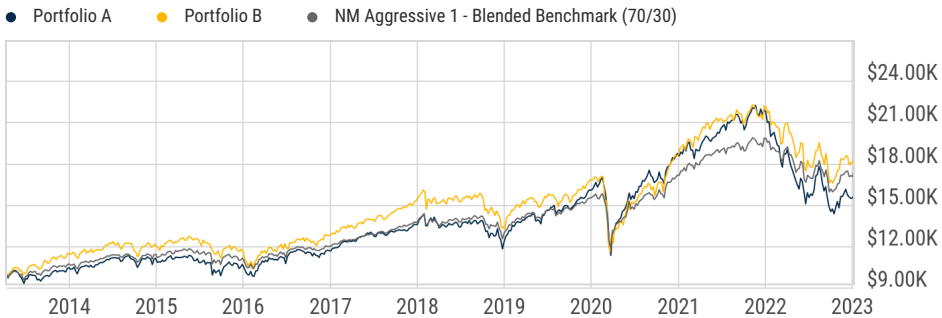

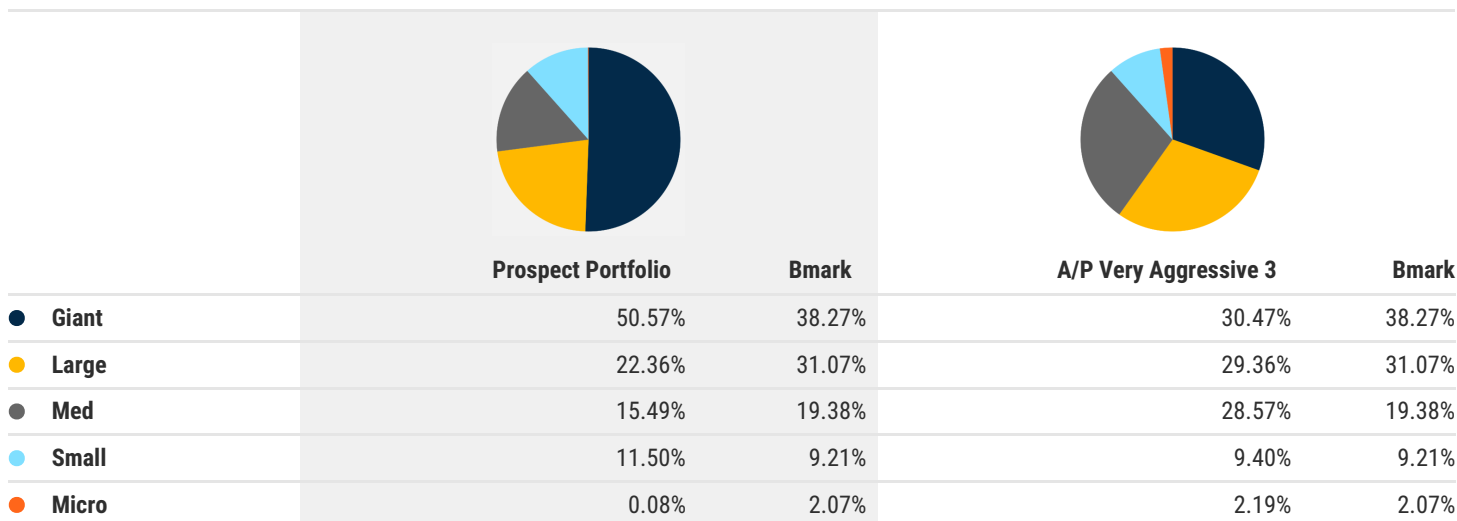
Asset Allocation
